Sir/Madam,

With reference to your online application dated 30/06/2012 on the subject cited above, I am directed to convey the sanction for Composite Provisional Affiliation for Secondary School Examination and Senior School Certificate Examination of the Board for a period of three years w.e.f. 01/04/2013 to 31/03/2016.

The following subjects have been sanctioned to be introduced at Senior Secondary classes :-

Subjects: English Core, English Core, Hindi Core, Hindi Elective, Physics, Biology, Chemistry, Computer Science, Informatics Prac., Accountancy, Business Studies, Economics, History, Geography, Political Science, Engg. Drawing, Psychology, Music (Vocal), Mathematics, Physical Education.

The above sanction is subject to fulfillment of following conditions:-

1. "School will follow the syllabus on the basis of curriculum prescribed by NCERT for the mid classes".
2. The school will implement Continuous and Comprehensive Evaluation (CCE) as per schemes of the Board upto Classes X.
3. As per the newly implemented CCE scheme vide Circular No. 39/20-09-2009 dated 20.09.2009, students of class X will appear in the Summative Assessment-II (SA-II) conducted at the school level only. However, those students of class X, who opt to move out of CBSE system in Class X to any other Board, will exercise the option to appear in the SA-II conducted at the Board level. Both the students will get the same certificate issued by the Board at the end of class X.
4. The school will follow the RTE Act, 2009 and instructions issued thereon by CBSE/Respective State Govt./UT.
5. It is mandatory for every affiliated school to become a member in the local Sahodaya of CBSE schools.
6. The school will follow syllabi and courses as per scheme of studies prescribed by the Board for Secondary School Examination and Senior School Certificate Examination and changes therein from time to time."
7. It will provide facilities for adequate co-curricular and extra-curricular activities for the wholesome development of the students.
8. It will abide itself by the Affiliation Bye Laws of the Board and other rules and regulations prescribed by the Board from time to time.
9. It is case of switch over from State Board; the school is required to withdraw its affiliation from such Board as dual affiliation is not permissible. Also State Board classes IX and XI will not be continued w.e.f. 01/04/2013. However, for the Class X and XII Examination to be held in the

10. The school will enroll students proportionate to the facilities available in the school as prescribed in the Affiliation Bye-Laws of the Board which shall not in general exceed the optimum number as under from Primary to Class XII :-

- (d) School running on bigger campus of more than 02 acres, the number of students shall be restricted as per the actual facilities in the school which shall be proportionate to the optimum number mentioned at (a), (b) and (c) above.
11. The School will not sponsor candidates for Board's examination of any other School/Branch, which is not affiliated.
12. The school shall sponsor regularly its bonafide and eligible students in Board's class X and Examination from the year mentioned above without break or inform with reasons thereof writing well in time about the non-sponsoring of the candidates. Failure to do so will lead to *s moto* withdrawal of the affiliation of the school for secondary Examination granted by the Board.
13. The school shall appoint qualified and trained teaching staff on regular basis as per provision of Affiliation Bye Laws of the Board.
14. Service conditions, pay and allowances and other benefits to the employees of the school shall be at least at par with that of corresponding categories of employees working in Government Schools of the State in which the school is located. An undertaking to this effect be sent to C.B.S.E.
15. Service agreement be executed with the staff as per norms generally accepted by the State Government concerned.
16. The school will help the Board in the smooth conduct of the examination by providing the necessary accommodations i.e. Rooms, Halls, etc. available in the school premises and furniture at its disposal for holding its examinations free of charges if required.
17. The school will spare sufficient teachers, for invigilation purpose at the examinations of the Board as may be required.
18. The school will spare its teachers for evaluation of answer-books for the Board's examinations, as required.
19. The school will provide Laboratories, Library and other facilities as per norms of the Board.
20. The school will abide itself by the conditions of affiliation already prescribed by the State Government concerned.
21. The school should have at least one adequately equipped computer lab with a minimum of 20 computers or computer student ratio of 1:20 and proper software alongwith facility of Broad Band Connectivity with the feature of 'internet always on' from any service provider.
22. The school shall promote inclusion of student with disabilities/special needs in the normal school as per provisions of the 'persons with disabilities act -1995'.
23. The school and its records shall be opened for inspection by an officer/official of the Board or authorized representative of the Board/State Educational Department at any time and the school shall furnish information as may be asked for by the Board/State Government from time to time.
24. The rate of tuition fee and other fees charged should be commensurate with the facilities provided.
25. The admission to the school shall be opened to all without any discrimination on the ground of religion, cast or race, place of birth or any of them.
26. No unrecognized classes shall run within the premises of the school or outside in the same name school.
27. The school will strictly adhere with all rules regarding safety of students including Fire fighting, Drinking water, Sanitation, Transportation, etc.
28. The accounts should be audited and certified by a Chartered Accountant and proper accounts statements should be prepared in the name of school, as per rules. A copy each of the Statements

32. The school will open CBSE pattern classes IX and XI w.e.f. 01/04/2013. Accordingly, 1st Batch of class X and XII of the school will be appeared at the Board's Examination to be held in the year 2015.

Conditions for which compliance to be submitted within three months from the date of issue of sanction letter:-

1. Running starting of Class IX/X & XI/XII without prior Provisional Affiliation upto Secondary level/Sr. Secondary level from the Board would be unauthorized and school shall be responsible for the consequences arising out of it.
2. Non-submission of application for extension of provisional affiliation by 30th June of the year preceding to the year by which provisional affiliation granted, expires, would also attract violation of provisions of Affiliation Bye-laws.
3. School will not prepare any student/start any class for any other Board except CBSE from their Affiliated school building/premises.
4. The Board would not allow any transfer of property/sale of school by one society/ Management/ Trust to another Society/Management/Trust through agreement/sale deed and the school shall not be closed down in the same premises. In case such transaction is effected explicitly or implicitly the Board shall withdraw its affiliation with immediate effect.
5. Pay & Allowances to staff should be revised from time to time to bring it at par with that to State Government.
6. The service conditions be strictly followed as per State Education Act and Staff be given appointment/confirmation letters etc. accordingly.
7. 5-6 names of persons (at least 2-3 from KV/JNV) not below the rank of Principal of Sr. Secondary School affiliated with the Board be recommended so that two of them may be approved by the Board as its nominee in the School Managing Committee.
8. The school shall maintain section teacher ratio at least 1:1.5 at each level i.e. Primary (I-V) Secondary (VI-X) and Sr. Secondary (XI-XII).
9. The school has to constitute a committee for protection of woman from sexual harassment at the work place and to abide by the guidelines and norms prescribed by the Hon'ble Supreme Court of India in W.P.
